Sub: Periodicity of inspection of the electrical installation by the electrical inspector or self-certification as the case may be -regarding.

Madam/Sir,

Central Electricity Authority (Measures relating to Safety and Electric Supply) Regulations, 2023 were notified by Ministry of Power on 08.06.2023. As per regulation 32 (2)-

Periodic inspection and testing of installations. - The periodicity of electrical inspection by the Electrical Inspector or the self-certification by the supplier, owner or consumer shall be as directed by the Appropriate Government:

Provided that the periodicity of electrical inspection and self-certification shall not exceed five years.

In view of the above it is informed that as per Order 23/06/2024-R&R dated 26.12.2024 of Ministry of Power (attached at **Annexure-I**) the periodicity of inspection by the authorised Electrical Inspector/ self-certification of the electrical installations belonging to or under the control of Central Government, **shall be five (5) years from the date of last inspection/self-certification**, irrespective of voltage level.

It is further requested that the application may be filed by the applicant **at least 6 months in advance** so that compliance and final approval is granted on time.

ORDER

Subject: Periodicity of inspection of the electrical installation by the Electrical Inspector/ self-certification - reg.

Under the provisions of Section 53 of the Electricity Act, 2003, the Central Electricity Authority (Measures relating to Safety and Electric Supply) Regulations, 2023, has been notified. These Regulations have provisions regarding periodicity of inspection of the electrical installations belonging to or under the control of Central Government.

2. In consultation with the Central Electricity Authority, it has been decided that the periodicity of inspection by the authorised Electrical Inspector /self-certification of the electrical installations belonging to or under the control of the Central Government, shall be five years from the date of last periodic inspection/self-certification, irrespective of voltage level. Such inspection/self-certification shall be carried out in accordance with the provisions under Central Electricity Authority (Measures relating to Safety and Electric Supply) Regulations, 2023, as amended from time to time.

3. This order shall supersede the earlier instructions by this Ministry, in this regard.

4. This issues with the approval of Competent Authority.
